## ADDITIONAL TERMS

### CLASS ATTENDANCE

The Student shall attend promptly and on-time for each and every class, being dressed in uniform and ready to start class at the appointed time. The Student shall, at all times, keep his/her uniform in a clean and presentable condition.

**WORLD SPORTS MISSION CANADA LTD.**, reserves the right to refuse to teach the Student, at any time and for any duration of time, if the Student is not on time for the scheduled lesson, his/her uniform, in the exclusive opinion of **WORLD SPORTS MISSION CANADA LTD.**, is not clean and presentable or for any other reason which **WORLD SPORTS MISSION CANADA LTD.**, in its exclusive and unfettered discretion, deems sufficient to refuse to teach the Student at any such time or duration of time.

**WORLD SPORTS MISSION CANADA LTD.**, Hereby expressly reserves the right, at any time and without notice of any kind to the Student and/or Co-signor, to alter the days and/or hours of operation and the class schedule(s) as it, in its exclusive and unfettered discretion, deems necessary from time to time. While **WORLD SPORTS MISSION CANADA LTD.**, shall make every effort to keep the Student informed, in advance, of any such changes, it shall not be bound, in any way, to do so.

### CANCELLATION

This agreement shall not be cancellable in any way unless provided for and strictly in accordance with the procedure below...

**Cancellation by WORLD SPORTS MISSION CANADA LTD.**, Reserves the exclusive right to cancel this agreement at any time and for any reason which it, in its exclusive and unfettered discretion, deems sufficient to cancel this agreement. In the event of cancellation of this agreement by **WORLD SPORTS MISSION CANADA LTD.**, any and all amounts due pursuant to this agreement shall become immediately due and payable by the, including any unpaid balance of the program fee, plus applicable H.S.T.

**Cancellation by the Student or Co-signor** – This agreement shall not be cancellable in any way by the Student or the Co-signor except, and only, as follows:

- (a) the Student or Co-signor may, within three (3) business days of the date of this agreement, cancel this agreement for any reason, provided the Student or Co-signor mails to **WORLD SPORTS MISSION CANADA LTD.**, by certified or registered mail to **385 JOHN ST. THORNHILL, ONTARIO, CANADA L3T 5W5**, written notice outlining the Student's or Co-signor's intention to cancel this agreement and the said notice is received by **WORLD SPORTS MISSION CANADA LTD.**, within three(3)business days of the date here of (any notices received after 10:00 p.m. on the third business day after the date hereof shall not be effective and no cancellation purportedly effected thereby shall be null and void); and
- (b) the Student or Co-signor may cancel this agreement at any time after the date here of only in the following circumstances:
  - A. the death of the Student.
  - B. the Student moves his/her residence outside of the Toronto & York Region & Peel Region or a distance of further than sixty (60) kilometres from **385 JOHN ST. THORNHILL, ONTARIO, CANADA L3T 5W5**

**Improper Cancellation by Student or Co-signor** – If the Student or Co-signor purports/attempts to cancel this agreement, other than in strict accordance with the terms of, **WORLD SPORTS MISSION CANADA LTD.**, They shall have no further obligation, as of the date of the purported cancellation, pursuant to this agreement and the full amount of the balance of the Program Fee, plus applicable H.S.T., shall immediately become due and payable by the Student and/or the Co-signor of **WORLD SPORTS MISSION CANADA LTD.** The said amount shall be retained by **WORLD SPORTS MISSION CANADA LTD.**, As liquidated damages and not as a penalty.

### TEMPORARY SUSPENSION OF ENROLMENT AGREEMENT

The Student or Co-signor may temporarily suspend the Student's enrolment pursuant to this agreement only in the event of medical illness or injury, which renders the Student disabled and unable to participate in classes. Any disability must be proven by a doctor's certificate, which must be accepted by **WORLD SPORTS MISSION CANADA LTD.**, in its reasonable discretion. The Student may be required by **WORLD SPORTS MISSION CANADA LTD.** to be examined by another physician designated by **WORLD SPORTS MISSION CANADA LTD.**, Prior to the acceptance of the doctor's certificate presented by the Student and by **WORLD SPORTS MISSION CANADA LTD.**

In the event of such disability, and acceptance by **WORLD SPORTS MISSION CANADA LTD.** The operation of this agreement shall be temporarily suspended for the duration of the Student's disability only, the duration shall be reviewed by **WORLD SPORTS MISSION CANADA LTD.** On a monthly basis or on such further or other period as **WORLD SPORTS MISSION CANADA LTD.** may, in its exclusive and unfettered discretion determine, and, which review may require the Student to provide further doctor's certificate(s) with respect to the Student's continuing disability and inability to attend and participate in classes.

This agreement shall not be suspended, in any way or at any time, unless as provided and in accordance with the procedure(s) expressly outlined herein.

### RELEASE & WAIVER OF LIABILITY

The student (or the Co-signor on behalf of, and as legal guardian of and agent for, the Student), on behalf of himself/herself, his/her heirs, executors, administrators and assigns, hereby releases, remises and forever discharges **WORLD SPORTS MISSION CANADA LTD.**, its directors, officers, employees, agents, associates and representatives from any and all claims, dues, demands, demands or damages arising from or out of, or in any way related to, any injury, loss, or damage sustained to the person or property of the Student, however caused, including the gross negligence of **WORLD SPORTS MISSION CANADA LTD.**, or its representatives, in connection with his/her participation in martial arts classes pursuant to this agreement, and any and all activities related.
